WHAT IS OFFERED

360 Yield Center will split the cost of qualifying marketing programs on a 50% / 50% basis with the Dealer, to an annual maximum reimbursement of \$2,000 (maximum annual reimbursement of \$3,000 if 360 Yield Center dealer net sales for the period 1/1/15 - 12/31/15 are greater than \$100,000). Expenses must be incurred between 1/1/16 - 12/31/16.

MARKETING PROGRAMS INCLUDED

A wide variety of marketing programs qualify for this reimbursement program. A partial list of the marketing items included are:

- Print advertising
- Radio advertising
- Online advertising
- Promo items ordered through 360 Yield Center's promotion sources
- 360 Yield Center wearables
- Exhibit space for trade shows
- Rental expenses for conference rooms and meeting space for customer meetings
- Printing and postage for direct mail
- Printing for promotional brochures
- Product display or demonstration stands

All covered programs must meet a few qualifying requirements:

- At least 50% of the effort must be devoted to 360 Yield Center products or services.
- For efforts that are shared with another supplier, the supplier must not offer products or services that are competitive with 360 Yield Center products or services.
- Reimbursement requires copies of invoices and some type of proof of execution, which could include an advertising tear sheet or affidavit, a photo of a display, a printer's proof of a sign, etc.
